CALL TO ORDER: Mayor Pro Tem Hobbs called the meeting to order at 6:30PM.

CITIZEN ADDRESSING THE COUNCIL:

Yvonne Johnson, Carbon County Economic Development Council Director addressed the Council. Ms. Johnson presented Museum Director Hobbs with a donated laptop from Trihydro, located in Laramie, Wyoming. The Council thanked her for securing the laptop and Hobbs will be sending a thank you to Trihydro.

REPORTS:

Fire Dept: No one from the Dept. was in attendance. Crane said the Dept. took delivery of the new side by side.

SCWEMS: SCWEMS has made an offer for a new the Ambulance Directors Position. They are still looking for a South end Station Manager.

Public Works: Director Page told the Council there had been a rise in COVID cases in town.

He told the Council he needed to replace the register and pumps on the fuel tanks. They will cost an estimated \$1800. This will be taken from the maintenance budget line item.

The Fire Dept. gave the town the old side by side that was used last year to spray mosquitos along the slough and for harder to reach areas. He priced a windshield and doors for the unit at \$600 which will be taken from Impact Funds-Public Safety.

Cm. Page made a motion to accept the quote from JN Enterprises to wire the cold storage building on Veterans in the amount of \$4,100; Cm. Mustard seconded the motion; Council Poll; Cm. Hobbs Aye, Cm. Page Aye, Mayor Irene Absent, Cm. Kennedy Absent, Cm. Mustard Aye, motion carries.

Director Page replaced the water heater at the water plant and will overhaul some leaking valves this month.

The sewer is working well. The needed replacement on the lagoon fence will cost approximately \$1,500. With the high cost of materials, he recommended postponing the project.

Director Page submitted the grant reimbursement to Carbon County Weed and Pest for mosquito chemical and administrative costs.

Director Page is looking for input to organize a committee for downtown beautification ideas. The town still has the banners that were on the light poles for the centennial. He would like to put them back up for the summer and fall season. Cm. Page said she would look into possible beautification grants to help the project. Interested residence please let the town hall know if you would like to help.

Director Page told the Council he has the invoice for repair to water pits ready to go to WyDot.

The street sign poles are in and the concrete needs ordered to set them.

WyDot is donating a sign trailer to attach our speed limit signs to.

The Council had a discussion on the purchase of a sand bagging machine and bags for \$15,000. **Cm. Page made a motion to not purchase the sandbagging machine and bags,** Cm. Mustard seconded the motion; Council Poll; Cm. Hobbs Aye, Cm. Page Aye, Mayor Irene Absent, Cm. Kennedy Absent, Cm. Mustard Aye, motion carries. Director Page audited the sandbags we have in storage and he estimated there are 700 viable bags.

Director Page wanted to Thank everyone that helped him with snow removal during our blizzard; Garrett Irene, Shae Johnson, Brent Kelly, Ken Casner, Mark Wagner, WyDot and Mayor Irene. He apologizes if he has missed anyone that helped.

HCJPB: Crane told the Council that she needed to resubmit one of the bills so thought maybe they were closer to reimbursing for the cameras and trash trailer.

Park Board: The Park Board hasn't had a meeting to start their season yet.

Museum Board: The auxiliary building has been ordered with an estimated July delivery date. Director Hobbs is getting brochures printed and getting quotes on magnets they will be selling to fundraise. May 29st is the official season opening of the museum with the 2nd Annual Ducky Race and Dutch oven cobbler. Director Hobbs shared that RV Bailey passed away. RV was a great supporter of the museum. His connection to the town came from his parents running the hotel during a portion of the big band era.

CCVC: Minutes were sent to the Council. The CCVC will meet at the hotel April 21st.
