HCJPB: The Mayor read a letter from Medicine Bow Mayor Kevin Colman stating that it has become clear that the three mayor need to meet to discuss the future garbage disposal for the three towns. He would like to invite the mayors to meet in Hanna in February at a date convenient to all. The Council discussed the various options the JPB has been considering. The Board approved bills in the amount of \$10,631.21. Mayor Irene accepted a letter of resignation from Judy Redding from the JPB. Mayor Irene has been filling in for Rep. Grillo in his absents and will take Redding's seat when Grillo returns.

Community Center/Phase 1 Update: Clerk Crane said she had contacted Mike Potter with Potter Architects to see what was holding up the fire marshal permit. He told Crane he would have the application on the Fire Marshals desk no later than the 9<sup>th</sup>.

Vistabeam Lease: The County Planning and Zoning contacted the office to let us know that Vistabeam needs a building permit from the county since the tanks are located in the county and not in the town limits. Crane passed this on to the representative from Vistabeam and they are working on get one.

**NEW BUSINESS:** 

Elk Mountain Trading Company: The town received a letter from Ken and Nancy Casner informing the Council of their seasonal closure starting 12-31-2016 to 06 09-2017. Because of a seasonal closure their requirement to purchase \$2,000.00 in product from the Wyoming Liquor Commission and other vendor can be prorated during the closure. Clerk Crane said she had spoken with the Commission and the renewal requirement will be \$1,000.00 for the year.

Vector Disease Control: The Town received a contract to renew with Vector for the aerial spraying in the 2017 Mosquito season. Cm.
