THE COUNCIL:

Bob Johnson addressed the Council about the possibility of the Cherokee Trails Homeowners Association interest in taking the Medicine Bow River Bridge when a replacement is installed. The contact for the homeowners association is Dan

APPROVE MINUTES: Mayor Irene asked for approval of the minutes. Cm. Booth motioned to approve

Reports were given by PMPC, the Fire Dept., SCWEMS, Water Dept., Zoning,

Public Works Dept., HCJPB, Park Board and Historic Trails RC&D.

PMPC: Keith reported that a letter had been sent to Water Drilling on November 17, 2011 concerning soft areas remaining after the mud pit reclamation and items remaining on the project site. They will inspect in the spring and at 11 months from substantial completion. The Water Meter project will have a kickoff meeting Tuesday, November 13th at 9:00a.m. Some of the meters have been delivered and expect the rest this week. Keith presented Pay Application #3 for High Plains Construction. Cm. Booth made a motion to approve Pay Application No. 3 to High Plains Construction in the amount of \$420,198.99 and \$46,688.76 to the retainage account; call for discussion on the numbers listed, Cm. Jones seconded the motion, Council poll; Cm. Booth Aye, Cm. Casner Aye, Cm. Hobbs Absent, Mayor Irene Aye, Cm. Jones Aye, motion carried. Keith updated the Council on the progress with the Tank and Transmission Line Project. The building is complete, tanks are erected, hydronic heat is installed and piping to wells are installed, site grading is complete, and they are working on the electrical and chlorination. Items remaining or not yet initiated are tank and pipe testing and disinfection, well pit less units and pumps, connecting piping at wells, SCADA, switch over to new wells, fencing and landscaping, and debris removal. It is a possibility that the contractor could be looking for a temporary shut down or a winter shut down. Keith made the council aware he would be asking for a Task Order Amendment 5 to increase construction phase services and initiate postconstruction services.

Fire Dept.: Chief Sherwood reported the Fire Department has had a slow month. John has added an addition to the front of the Fire Department to block wind and ice buildup.

SCWEMS: Has had one ambulance call.

REPORTS:

<u>WATER:</u> Pat Eastman reported he is back on artisan flow and the valves are working fine.

Zoning: Nothing to report

<u>Public Works:</u> Public Works Director Larsen reported that Six Points from Laramie did the sewer line repairs on Main and Evans Streets. He installed the lighted exit signs in the Senior Center and completed the landing out the secondary exit to comply with the fire marshals' requests. John said the lift station is running at 5.7%.

<u>HCJPB</u>: The Mayor reported he had attended the meeting hosted by Elk Mountain. They discussed reorganizing the employee handbook, time cards and the office in Hanna. Don Quinn from the Rawlins Landfill presented options for the landfill to take our trash to Rawlins. The Board went into executive session and upon exiting took action to release the HCJPB clerk/treasurer from their employment.

HTRC&D: Nothing to report.

<u>Park Board:</u> Dorothy Booth reported the Board is looking at fundraising to help cover expenses at the park. They plan to bury the electrical wire from the shelter to the pole. There has been work on the ice rink.

Mayor Irene informed the Council that a glitch in the new Black Mountain software omitted the usage charge on the utility billing for November. Cm. 2nd Amendment to the HCJPB Agreement: The Town of Hanna is reviewing the final agreement at their council meeting on Tuesday, November 13, 2011.

<u>Carbon County Consensus Funding:</u> The grant for the Consensus Funding was approved by SLIB on October 6, 2011. The town has until October 6, 2012 to complete the work on the Sewer Project.

<u>WAM Scholarship Applications</u>: There are applications for the February Winter Workshop in Cheyenne and the June Convention in Laramie.
