CITIZENS ADDRESSING THE COUNCIL:

Ken Casner asked a question pertaining to the Council decision on the natural gas issue. The Council had decided by resolution to pursue bringing natural gas to town on the next round of the 6th penny tax. He also asked about the plans for the redundant water line project and if there were diagrams showing the project layout. There is a copy in the office but because of size PMPC will send out a

scaled down version that could be printed.

REPORTS: Reports were given by Fire Dept., SCWEMS, Water Dept., Zoning, Public Works

Dept., HCJPB, Park Board, Cemetery Board, Juvenile Services, CCEDB and

CCCOG.

Fire Dept.: Chef Sherwood was not in attendance; Bob Meyer told the Council that the fire department had a few calls this month. The Department will be

holding elections next month.

SCWEMS: Representative Sikes was unable to attend the meeting. Clerk Crane said the EMT classes were still being conducted and that the bookkeeping records were in review at the accountants.

Water: Water Superintendent Eastman told the Council that the radium 228 and the radium nuclide have been retested and they are down to a 1.2 reading. Eastman said the heating system is working after repairs and the chlorine reading have been remaining consistent. The tanks are on artesian flow.

Zoning: No Reported.

<u>Public Works:</u> Public Works Director Martinez said the equipment is back to running properly. WyDot opened the corner of Balsam and Elk and because of the drifting potential the Mayor told Martinez to just leave it for the remaining season.

HCJPB: Representative Hobbs said that the landfill ratified bills in the amount of \$11,991.92. They will probably need to redrill a well onsite because of a collapse. Chairman Gonzales is in communications with DEQ to see if this well needs to be redrilled. The Board will be doing interviews for the bookkeeper positions on the 24th. The Board is looking into acquiring some roto-mill and disposed of 14.5 ton of used tires. Rep. Hobbs said the meeting with Rebecca Derrick, WDEQ went well and they discussed contour plans for the landfill. They were told that the cease and transfer funds will need to be applied for through the HCJPB. They are in discussion with an attorney for a social security situation with employee Mike Martin.

Park Board: Clerk Crane told the Council she had spoke with Dan Cobb about the cabin the Board and Mr. Cobb are in discussion about donating.

Cemetery Board: No Report

Juvenile Services: No Report

<u>CCEDB</u>: The Mayor presented the Council with a proactive economic development business plan to improve the economic performance and vitality of Carbon County. He requested the Council review the document and give feedback on the goals. He said one of the projects the EDC was trying to develop was a rail siting that could help with the logging and uranium growth on this side of the county.

<u>CCCOG</u>: The Ad Hoc committee is working on the informational postcards for the 5th penny tax.

TREASURER'S REPORT:

Treasurer Crane recommended to the Council to approve the January treasurers report as presented. **Cm. Hobbs made a motion to approve the January treasurers report;** Cm. Page seconded the motion; Council Poll; Cm. Hobbs Aye, Mayor Irene Aye, Cm. Jones Absent, Cm. Meyer Aye, Cm. Page Aye, motion carried.

BILLS TO BE PAID:

Treasurer Crane recommended ratifying and paying the bills in the amount of \$18,161.64. Cm. Hobbs asked what the Dave Jeffers charge was for; Treasurer Crane said it was for the Public Works Computer. Crane also told the Council the check to the Senior Center Board was for a new microwave and that the funds came from their line item in the budget. Cm. Meyer motioned to ratify and pay the bills from January 15th thru February 10th in the amount of \$18,161.64; Cm. Hobbs seconded the motion, Council poll; Cm. Hobbs Aye, Mayor Irene Aye, Cm. Jones Absent, Cm. Meyer Aye, Cm. Page Aye, motion carried.

Meyer Aye, Cm. Page Aye, motion carried. Cm. Hobbs made a motion to allow Mayor Irene to sign the Notice to Proceed, Cm. Page seconded the motion; Council poll; Cm. Hobbs Aye, Mayor Irene Aye, Cm. Jones Absent, Cm. Meyer Aye, Cm. Page Aye, motion carried.
